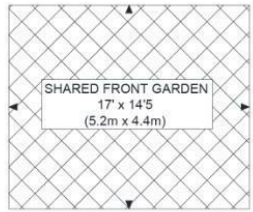

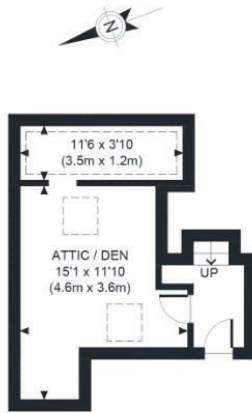
GROUND FLOOR

FLOOR AREA 657 SQ FT

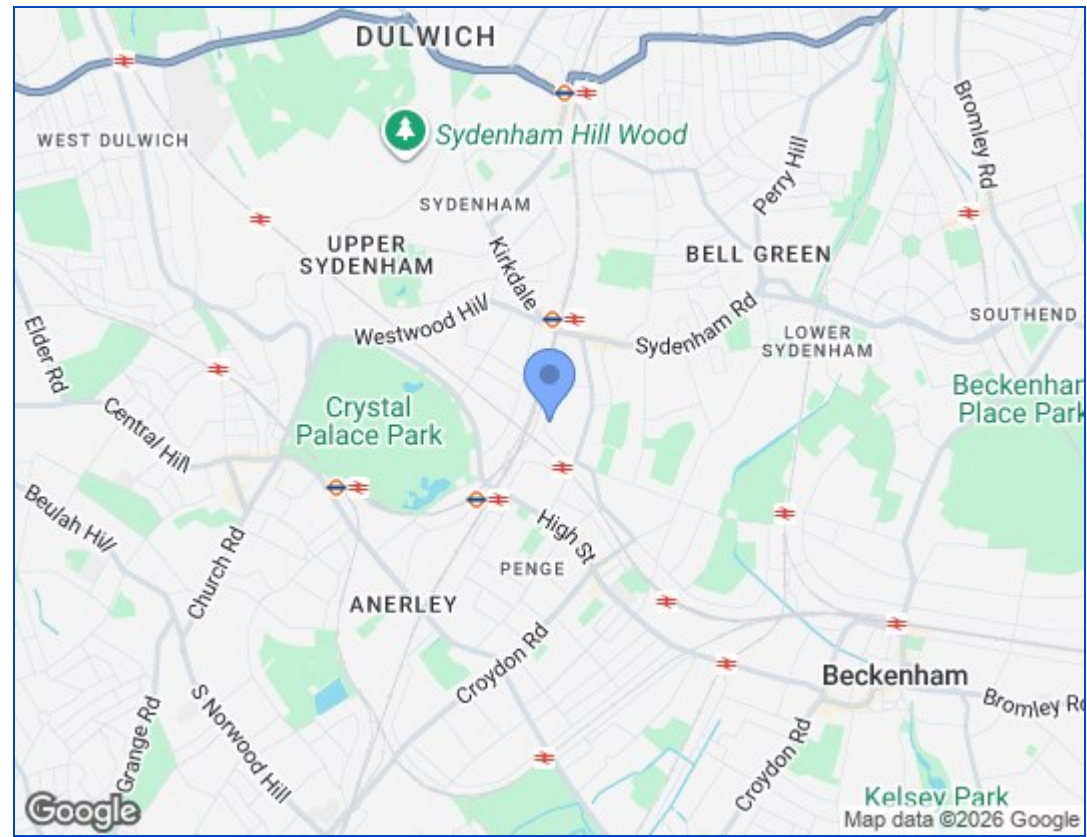


LOFT
