### LOCATION - WHITCHURCH

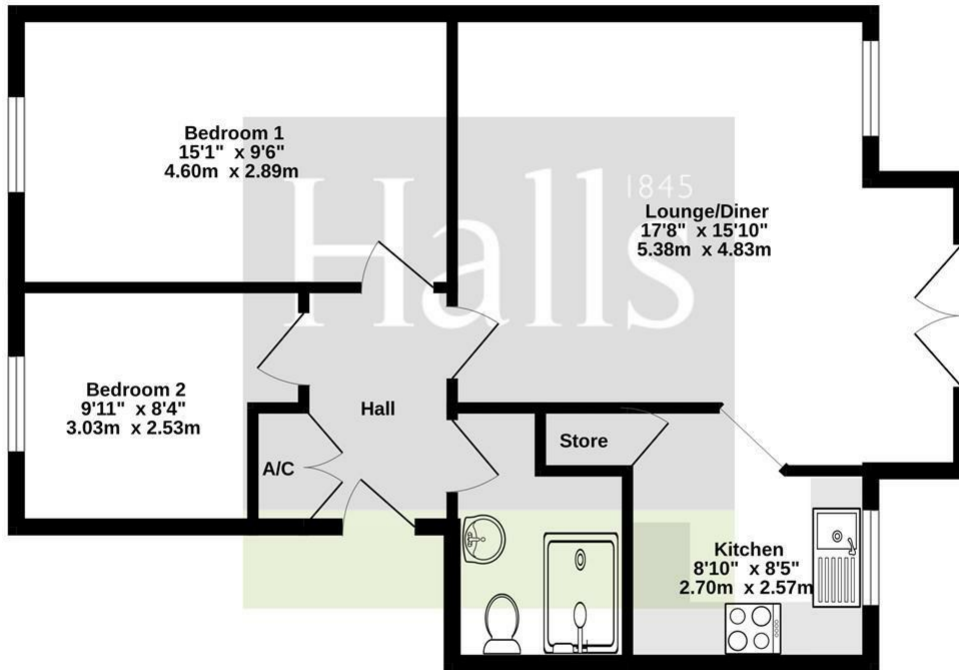
